Subject:- Filling up of the post of Deputy Director(Accounts) in the Pay Scale of Rs. 10,000-15,200 (Pre-revised) on deputation basis (ISTC) in the Directorate of Extension, Deptt. of Agriculture & Cooperation .

Sir,

I am directed to say that one post of Deputy Director (Accounts) in the scale of pay of **Rs.10,000-15,200/(Pre-revised)**, General Central Service, Group 'A', Gazetted, Non-ministerial is proposed to be filled in the Directorate of Extension on deputation(ISTC) basis for a period not exceeding 4 years from the date of its filling up of the from amongst the

I. Officers under the Central Government,

- (a) (i) Holding analogous post on regular basis in the parent cadre/Department; or
- (ii) With 6 years service in the grade rendered after appointment thereto on regular basis in the scale of pay of **Rs.7500-12000(Pre-revised)** or equivalent in the parent cadre/Deptt.; or
- (iii) With 8 years service in the grade rendered after appointment thereto on regular basis in the scale of pay of **Rs.6500-10500(Pre-revised)** or equivalent in the parent cadre/Deptt.; and

(b) Possessing the educational qualifications and experience prescribed for direct recruit as under:

- (i) Degree of a recognized University or equivalent;
- (ii) A pass in the Subordinate Accounts Services or equivalent examination conducted by any of the organized Accounts Departments of the Central Government.
- (iii) Six years experience of Accounts work in the Government offices

II. The Departmental Assistant Accounts Officer in the pay scale of **Rs. 6500-10,500 (Pre-revised)** with **eight years regular service** in the grade shall also be considered along with outsiders. In case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion. The Departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed 4 years. The maximum age limit for appointment by deputation should not exceed 56 years as on the closing date of the receipt of applications.


2. Officers selected will have the option to draw his Grade Pay plus Deputation(duty) Allowance or to have his pay fixed in the scale of pay of the post in accordance with the Department of Personnel and Trainings O.M. No.2/29/91-Estt.(Pay II) dated 5.1.1994.

3. It is requested that the applications (3 copies) in the enclosed proforma along with the complete and up-to-date Confidential Reports dossiers of the officers who are willing to be considered and can be spared may kindly be forwarded to this Department within 60 days from the date of publication of this vacancy in the Employment News/Rojgar Samachar. While forwarding the applications it may also be forwarded and certified that particulars furnished by the officers are correct and that no vigilance case is either pending or contemplated against them and that their integrity is certified. It may also be certified that no major/minor penalties have been imposed upon the officer during the last ten years.

4. Applications received after the last date or without the up-to-date C.R.s, integrity and vigilance clearance or otherwise found incomplete will not be considered.
